*From Senate Bylaws/Senate Procedures II:*

*The President of the Senate shall appoint a Nominations and Elections Committee of three (3) Senate members by February of each year and submit a call for elections by the end of February. Candidates may be either nominated by fellow faculty members or self-nominate. Nominated faculty shall provide a statement of candidacy to the Nominations and Elections Committee for inclusion with ballot materials.*

*Nominations will close 30 days after they are opened. Nominated faculty may state their candidacy publicly at any point in the process, and at the faculty Senate meeting following the closing of nominations. Candidates will have three minutes to speak.*

*Voting will be handled electronically by the Nominations and Elections Committee. The Committee will send electronic ballots within five (5) working days after nominations are closed and tallied when the election window closes ten (10) days after the electronic ballots are sent.*

*Nominations for the Adjunct Faculty Representatives will be handled in the same manner; elections will be handled electronically by the Junior Adjunct Senate representative each year.*
