

must be submitted to the curriculum workflow alongside any modifications to existing programs or new program proposals. Note: Faculty must include new courses as placeholders in their programs before submitting them to the workflow with the new course(s).

- 2.3 Financial Aid New Gainful Employment Program Length Restrictions and SOC Codes (needs action)
  - Programs require the following criteria for financial aid submission and eligibility approval:
    - Standard Occupational Codes (SOC) Faculty response needed by September 23, 2025.
      - SOC codes classify work roles into occupational categories based on job duties.
      - Active Credit Certificate Report Faculty to add SOC codes by September 23, 2024.
         (distributed via emailed 9/5/24)
      - o SOC/CIP Crosswalk
        - Use the crosswalk above to identify an appropriate SOC code that aligns with the CIP and TOP codes for each certificate and add to above Active Credit Certificate report.
      - Add the appropriate SOC code to the shared Credit Certificate Report above.
      - Due by September 23<sup>rd</sup> to continue financial aid eligibility of certificates. Note: If the SOC code is not received financial aid eligibility will be interrupted for students.
    - Program Length Restrictions (court injunction at this time)
    - Delivery Method (Lead Curriculum Specialist will work with CourseLeaf and/or IT to develop a format and formula via Excel)
      - o Programs must list the % of distance education offered

<u>Chancellor's Office memorandum</u> dated 9/6/2024 lists this announcement and courses:

The CCN Council and Developmental Workgroup have selected the Phase II courses. While all the process specifics have not been finalized, the ASCCC and the CCN Workgroup are evaluating what worked well during Phase I to inform the Phase II process. Here is the list of proposed Phase II courses.

- CIM Cal-GETC GE fields will be added by late November. GE requests for the COMM courses will be tracked in a shared spreadsheet until they are approved.
- Programs with Cal-GETC language change only that do not need other updates:
  - o List "Changing CalGETC language only" in the Program Rationale
  - In the CIM program and Narrative Word document change the IGETC language to Cal-GETC
- Programs that require the Cal-GETC language and other updates:
  - o List "Changing CalGETC language only" in the Program Rationale
  - In the CIM program and Narrative Word document change the IGETC language to Cal-GETC
  - Add Phase 1 CCN courses to Program Requirements where applicable
  - Check <u>Course Impact Report</u> to see if any courses and programs need to be updated. Reviewing this report regularly and making course requisite and program updates helps ensure accuracy in the Catalog.

- 3.2 The Chancellor's Office COCI Database Week Long Closure Maintenance Periods impact the curriculum approval and implementation timeline:

## Closure Weeks:

- o October 28<sup>th</sup> November 3<sup>rd</sup>
- January 8<sup>th</sup> 14<sup>th</sup>
- 3.3 Chancellor's Office Approval Time Frame:
  - Two staff members are reviewing programs for the 115 Community Colleges.
  - The Chancellor's Office approval timeline has increased from 60 days to 90 to 100 or more days due to limited staff.
  - For programs that are submitted and returned for revisions the approval window of 90 to 100 or more days starts over.
  - As a result of the COCI maintenance closure and approval time frame, programs may not be approved by a desired effective term. Faculty need

to monitor their email from the Curriculum Team (Chair, Articulation Officer and Curriculum Specialists) and prepare to make program revisions on a short timeline as needed.
