DRAFT Resolution Regarding Faculty Development Funding Expenditures

Whereas, faculty development funds are limited each academic year to \$42,000, and

Whereas, the number of faculty eligible to use said funds grows each year, and

Whereas, in the past few years tracking expenditures has been difficult and resulted in non-approval of funding requests when it was discovered later that funds were available.

Therefore, be it resolved;

As of the 18/19 academic calendar all faculty requesting and using faculty development funds for professional growth will be required to abide by the following reimbursement requirements:

- 1. When applying for faculty development funding, faculty are advised to check with their deans to see if alternative sources of funding might be used prior to requesting faculty development funds.
- 2. Faculty who are awarded faculty development funds for travel/professional growth, must submit their receipts for reimbursement no later than 30 days following the event.

- 3. Any unclaimed funds will be returned to the faculty development fund for reallocation and the faculty member who originally requested said funds will forfeit reimbursement.
- 4. Any faculty member who is awarded funds and subsequently does not use said funds is requested to notify the committee as soon as possible so that said funds can be reallocated.
