FULL TERM CLASSES These dates apply to regularly scheduled classes meeting the full length of the term.

- January 19 Deadline to submit Residency Appeal.
- January 26-31 Open enrollment continues and as classes and waitlist fill, an Authorization to Add is required. [View Important Section Dates](#) in your MyCOD Student portal, or click on Catalog & Schedules on the college website to verify if a course requires Authorization to Add
- January 29 Spring Classes Begin
- January 31 At 4:59 p.m., last day to add a full term class that is not filled without an Add Authorization
- January 31 At 5:00 p.m., Authorization to Add is required to add or register full-term courses in Self-Service.
- February 5 Last day to add full-term classes. For late start courses go to Self-Service, enter any start date after February 5.
- February 11 Last day to drop full-term classes and qualify for refunds. Students enrolled beyond this date are financially responsible for their fees.
- February 11 Last day to drop full-term classes without a grade of "W".
- February 12 Census due for full term classes that start January 29th.
- February 16-19 Presidents Weekend Holiday - CAMPUS CLOSED. No scheduled classes.
- March 1 Last day to submit Spring 2024 Application to Graduate.
- March 25-29 Spring Break (No Saturday, Sunday classes on March 30 and 31).
- April 26 Last day to drop full-term classes with a grade of "W".
